July 11, 2017

The meeting of the McCook County Commission was called to order in their Meeting Room by Chairman Steve Gordon. Members present: Ralph Dybdahl, Charles Liesinger, Dean Koch and Marc Dick.

Chairman Gordon led the Pledge of Allegiance.

Chairman Gordon called for approval of the proposed Agenda. Auditor Sherman noted an addition at 10:00 a.m., Sheriff Mark Norris. Motion made by Koch to approve the Agenda adding Norris at 10:00 a.m. Second by Liesinger and motion carried.

Auditor Sherman noted a correction to the June 13th minutes with reference to a bridge project; the bridge number is 44-180-068, not 44-160-068 as originally noted. The minutes from the June 27th meeting were sent to Board members for review prior to publication. Motion made by Dybdahl to correct the June 13th minutes and approve the June 27th minutes for publication. Second Koch and motion carried.

Commissioner Reports: Koch and Gordon attended the Dept of Legislative Audit Budget Training workshop held in Pierre. Koch noted that the Food Pantry Board has finalized By-Laws and Articles of Incorporation and has scheduled a training session for Food Pantry volunteers. Koch and EDS Director, Brad Stiefvater, met with the Senator Rounds representative, who was at Salem City, regarding the changes being made to the County's Floodplain map; huge changes are being made to the entire County including rural areas and within the municipalities. Koch noted that he, Comm Gordon, Sheriff Norris, Hwy Supt Kreutzfeldt and Auditor Sherman met with Brian Mundahl, US Department of Labor Wage and Hour Division for a compliance investigation. And this morning Koch and Gordon met with Hwy Dept employee representatives; main discussion regarding HR concerns.

Mic Kreutzfeldt, Hwy Supt, presented 2 resolutions with reference to grant applications for bridge engineering. Motion made by Dick, second Dybdahl, and carried to approve the following resolution:

Kreutzfeldt informed the Board that the bid letting for Bridge 44-101-110 (255th St @ 440th Ave) will be held tomorrow in Pierre. Discussion was held regarding bonus pay currently received by employees who spray weeds or operate oil distributor. Kreutzfeldt asked the Board to consider a clothing allowance for these employees instead to eliminate overtime pay issues. Kreutzfeldt noted that due to increased requests for dust control, a policy is needed for these requests; McCook County will do prep work and water prior to

application of product which is at the requesting party's expense. Currently chip sealing with Lake County.

No drainage permits.

Mark Norris, Sheriff, joined the meeting. Norris asked the Commissioners if they want to cut Contract Law Enforcement or keep it going; he's had enough. The Board told Norris to keep it going. Sheriff Norris presented a letter of resignation from Kipp Stearns effective July 14, 2017, to the Board and noted that he'll begin the process of searching for another deputy.

Motion made by Koch to convene as Board of Adjustment. Second made by Dick and motion carried.

At 10:30 a.m. a public hearing was held to receive input concerning a request for a Conditional Use. Applicant: Tim Reynolds, property owner Deborah Reynolds Living Trust. Legal description is South 1000 feet of North West Quarter, Section 33 and North 1500 feet of South West Quarter, Section 33 Township 104, Range 53. Present were: Mike Kane, Jim Miles, Roger Kipp, Ramsey Twp, Rita Lampe, James Reynolds, Sheryl Johnson, and Glenn Boomsma, Attorney, Roger Gerlach, Attorney, and Tim Reynolds. Donald DeKnikker, Zoning Assistant, presented public hearing guidelines and Zoning Staff Report. Hwy Supt Kreutzfeldt voiced concerns regarding posted bridges in the area and dust control for residences. DeKnikker, Kreutzfeldt and Tim Reynolds answered questions from

Board of Adjustment. At this time, public testimony was opened. Glenn Boomsma, Attorney for Sheryl Johnson, stated his clients

concerns of dust, noise, traffic and safety. Boomsma offered the following solutions; Reynolds could use 249th St/ 450th Ave or access 450th Ave further south or possibly go east through the Vermillion River to Valley Rd. His client doesn't want Reynolds to be shut down. Tim Reynolds noted that he doesn't want issues for neighbors and he would place product on the road for dust control. He added that the Minimum Maintenance Rd, 249th Ave, was too narrow to be used but he would be willing to move driveway south of its current location on 450th Ave. Sheryl Johnson expressed her concerns about dust control and access to her property due to truck traffic. Roger Gerlach, Attorney for Reynolds, asked Johnson how often she goes in and out of the property in a day. No definite answer was given. Tim Reynolds stated that he wasn't expecting high traffic in and out of the pit. Kreutzfeldt added that 450th Ave north to 249th St is not a viable option. Jim Miles, Ramsey Twp, noted that the traffic on 453rd Ave is much heavier with a lot more dust. Mike Kane, Ramsey

Twp, agreed that the 249th St, Minimum Maintenance Rd, isn't an option because it is very narrow with steep ditches. Rita Lampe, adjacent land owner, asked the Board if going east through the river is even an option. Board Members answered, no. At this time, public testimony was closed. Board of Adjustment discussion followed. Board Member Gordon noted that this is a "living in the country issue". Board Member Koch stated that he feels the river route isn't an option and posted bridges can't be used but dust control can be done in front of Sheryl's home and a driveway can be placed as far south of her home as possible. A new driveway location was suggested by Tim Reynolds and measured by DeKnikker on the country GIS mapping to be 551 feet south of Johnson's property. Board Member Dick suggested a condition of the permit should be that the driveway be moved 500 feet more or less south of Johnson's property. Johnson asked who would maintain the road. Kreutzfeldt stated that maintenance would be taken care of by the township but generally the hauler assists in maintaining the road to a degree because they need to get their trucks in and out using the road. Motion made by Liesinger to approve the Conditional Use Permit with the following conditions noted: move driveway 500 feet or more south of property legally described as the East 477 feet of the South 916 feet of the North East Quarter, Section 32 Township 104 Range 53 and dust control in front of homesteads per landowner request on 250th St east of 450th Ave to Valley Road. Second was made by Dick. Aye votes: Liesinger, Dick, Dybdahl, Koch and Gordon. Nay votes: none. Motion carried.

The Board reconvened as Board of County Commissioners.

Alicia Petersen, 4-H Youth Advisor, met with the Board to review the Extension and Fair Board budget requests for 2018.

Geralyn Sherman, Welfare Director, and the Commissioners reviewed Care of Poor cases and the list of lien payments received in June. A Notice of Hospitalization was received from Avera McKennan Hospital (2017-30). A Notice of Hospitalization was received from Sanford USD Medical Center (2017-31). An individual did pick up an application for county assistance for a hospital bill (2017-28) and this hasn't been returned.
