December 29, 2016

The meeting of the McCook County Commission was called to order in their Meeting Room by Chairman Ron Scharffenberg. Members present: Ralph Dybdahl, Sheldon Butzke, Steve Gordon and Marc Dick. Commissioners-Elect Dean Koch and Charles Liesinger were also present.

Chairman Scharffenberg led the Pledge of Allegiance.

Chairman Scharffenberg called for approval of the Agenda. Auditor Sherman noted addition of Sharon Hieb at 11:00 a.m. Motion made by Gordon to approve the Agenda with addition noted. Second Dybdahl and motion carried.

The minutes from the December 13^h meeting were sent to Board members for review prior to publication. Chairman Scharffenberg called for approval of same.

Motion made by Butzke to approve the minutes for publication. Second Gordon and motion carried.

Commissioner Reports: none.

Hwy Supt, Mic Kreutzfeldt, asked the Board about scheduling the annual Township meeting that is held in February, adding that this year we'd like to invite the cities to a morning meeting and meet with the townships in the afternoon. The date of February 17th was selected. Auditor Sherman and Kreutzfeldt will put together information for the cities to see if there is interest in attending. Kreutzfeldt informed the Board that he is reviewing options for a 1Ton truck which is budgeted for purchase in 2017. With regard to the gasoline issue, a hydro filter has been placed on the gasoline dispenser located at Hwy Dept and this has helped; no problems since the change. At this time, the Sheriff's Dept is still purchasing gas. January and February, winter hours are

7:30 a.m. to 4:00 p.m. for the office and 7:00 a.m. to 3:30 p.m. for Hwy Dept crew. States Attorney, Mike Fink, joined the meeting; no agenda items but did discuss jail costs and commented that he thought the drainage ordinance is working well compared to counties that have abandoned theirs. Kreutzfeldt and the Board reviewed major projects scheduled for 2017; including chip sealing, bridge repairs/replacement and gravel crushing. Current projects include brush removal and year-end inventory.

Motion made by Gordon to convene as Drainage Commission. Second by Dybdahl and motion carried.

Drainage Administrator Kreutzfeldt presented the following drainage permit application, noting that downstream landowner signatures were obtained and he has signed off on it:

Brad Stiefvater, EDS Director, asked to join the meeting. Stiefvater wanted to inform the Board that Homeland Security is looking at cyber security and possibly making grants available in the future. Stiefvater will keep the Commission updated.
