July 28, 2015

The meeting of the McCook County Commission was called to order in their Meeting Room by Chairman Ralph Dybdahl. Members present: Sheldon Butzke and Ron Scharffenberg. Members absent: Steve Gordon and Marc Dick.

Chairman Dybdahl led the Pledge of Allegiance.

Chairman Dybdahl called for approval of the Agenda. Motion made by Butzke to approve the Agenda. Second made by Scharffenberg and motion carried.

The minutes from the July 21st meeting were sent to Board members for review prior to publication. Chairman Dybdahl called for approval of same. Motion made by Scharffenberg to approve the minutes for publication. Second Butzke and motion carried.

Commissioner Reports: none.

Mic Kreutzfeldt, Hwy Supt, presented a utility permit for approval for TM Rural Water District. Motion was made by Butzke to approve the Water Utility Permit, authorizing Chairman Dybdahl to sign same. Location of installation: intersection of 261st St & 449th Ave. Second made by Scharffenberg and motion carried. Kreutzfeldt presented 3 utility permits for Southeastern Electric. 1. Location of installation: 43384 261st St, Bridgewater; installing primary single phase. 2. Location of installation: 26034 435th Ave, Bridgewater; installing primary single phase. 3. Location of installation: 43270 261st St, Emery. Motion was made by Scharffenberg to approve the Electric Utility Permits, authorizing Chairman Dybdahl to sign same. Second made by Butzke and motion carried. Kreutzfeldt presented the following quotes for #2 dyed diesel fuel: Cole's Petroleum \$1.6972/gallon; Central Farmers Coop \$1.739/gallon; and Country

Pride Coop \$1.74/gallon. Motion made by Butzke to accept quote from Cole's Petroleum. Second made by Scharffenberg and motion carried. Kreutzfeldt and the Commission reviewed the Local Bridge Improvement Grant Requirements, the County Hwy & Bridge Improvement Plan Requirements, and the Local Bridge Improvement Grant Procedure. Current projects include asphalt spot repair and hauling gravel along with finishing chip sealing in Lake County.

No drainage permits to present.

Fred Butzke, District Project Coordinator, Linda Neve, Office Manager, George Leitheiser, Ron Sandine and Brian Smith, Board Members, McCook Conservation District, met with the Commissioners to discuss \$20,000 budget request for 2016 for the District. Services and products for landowners were reviewed; including tree planting, equipment rental and grass seed and cover crop mix sales.

Welfare Director Sherman, Mariann Oyen, Benefits Specialist, and the Commissioners reviewed Care of Poor cases. Two Notices of Hospitalization received from Avera McKennan Hospital; one returned because individual isn't a McCook County resident (2015-39). One Notice of Hospitalization received from Avera Queen of Peace Health Services (2015-42). One Notice of Hospitalization was received from Sanford Medical Center (2015-40). Sherman noted that numerous requests are being received by ICAP and Auditor's Office for utility bills from Xcel Energy. An Application for County Assistance for a \$1783.kk Xcel Energy bill was denied (2015-41). A Hospital Request for Payment from Sanford Medical Center was denied; individual hasn't applied for assistance (2015-38). Kris Graham and Laura Boone, Southeastern Behavioral HealthCare, met with the Commissioners to discuss 2016 budget request of \$5618 and review services provided. Funds received are used to subsidize outpatient services including individual counseling, family and group therapy, psychiatric services and home based family treatment. In addition, funds are utilized for specialized treatment services for children with emotional disturbances as well as for therapeutic and support services for individuals, with severe mental illness when the need exceeds the state allocated funding.

Motion made by Butzke to convene as Planning Commission. Second Scharffenberg and motion carried.

At 11:15 a.m. a Conditional Use Hearing was held as advertised. Applicants: David & Amanda Olson. Legal description: 1 acre in the Re-plat of Lot 1 in SE4 12-101-56. Reason for conditional use: telecommunications tower. Present: David Olson and Zach Nelson, Verizon Wireless, representative. Tracy Hofer, Zoning Administrator, informed Board that in order to approve the request for conditional use, a "majority vote" is required, meaning we need four board members present. Auditor Sherman placed a call to Commissioner Gordon, no answer. A call was then placed to Commissioner Dick who was reached in Fairbanks Alaska. © Hofer explained the reason for the call and proceeded with the hearing, presenting information for the Conditional Use Permit Application. Conditions required: Bridgewater City Permit #57/2015 approved by City and apply for separate 911 address for tower. Following discussion, motion was made by Butzke to approve the conditional use permit. Second was made by Scharffenberg. Ayes: Butzke, Scharffenberg, Dick and Dybdahl. Nays: none. Motion carried.

The Board reconvened as Board of County Commissioners.

In other business, Hofer informed the Board that she has offered the position of Staff Appraiser to one of the applicants. Hofer also wanted to verify that this individual will receive \$3000 for the position of Planning & Zoning Secretary and asked about the effective date. The request for the secretary is approved for the 2016 budget, so that will be the effective date for the pay to begin.

Missy Lauck, CHN, presented her 2nd Qtr Report to the Commission giving explanation of information provided. Lauck noted that the office is quite busy and adding another day for seeing clients is something she plans on discussing with her Supervisor. She will keep the Commissioners informed.

Time was spent reviewing 2016 budget expenditures and revenues.

Motion made by Scharffenberg to authorize Chairman Dybdahl to sign the 2015 Emergency Management State and Local Agreement. This is a 50% grant; therefore the county must match up to the final amount awarded with non-federal funds. Second by Butzke and motion carried.
