The meeting of the McCook County Commission was called to order in their Meeting Room by Chairman Ron Scharffenberg. Members present: Ralph Dybdahl, Sheldon Butzke and Steve Gordon. Member absent: Marc Dick.

Chairman Scharffenberg led the Pledge of Allegiance.

Chairman Scharffenberg called for approval of the Agenda. Motion made by Butzke to approve the Agenda. Second Dybdahl and motion carried.

The canvas of votes from the June 7th, Primary Election, was held. The Poll Books were reviewed with the number of voters compared to the ballots counted in each Precinct and to the Recap Sheet for the respective Precinct. No discrepancies were noted.

The minutes from the May 24th meeting were sent to Board members for review prior to publication. Chairman Scharffenberg called for approval of same. Motion made by Butzke to approve the minutes for publication. Second Gordon and motion carried.

Commissioner Reports: Butzke noted that he accompanied Gary Parry, Weed Supervisor, to survey County right-of-ways and areas of concern regarding weed control. A Weed Board meeting is scheduled for Friday, June 17th, at 3pm. Gordon stated that he attended a meeting held in Mitchell regarding the County Master Transportation Plan, with Hwy Supt Kreutzfeldt and EDS Director Stiefvater. Kreutzfeldt will give an update today.

Mic Kreutzfeldt, Hwy Supt, and the Board discussed Resolution 2016-03, Resolution Setting Traffic Controls on 446th Ave in Canistota. Motion was made by Gordon to rescind Resolution 2016-03 because the intended swap of 446th Ave and Railway Ave was never legally completed leaving that segment under Canistota City

jurisdiction. Second made by Butzke and motion carried. Kreutzfeldt noted that

Canistota City has requested that the crosswalk sign/light intended for 446 Ave at Main

St be placed on Railway Ave at Main St instead; agreed. Kreutzfeldt updated

Commission on the Transportation Planning Meeting held in Mitchell, attended by him,

Stiefvater & Gordon. At this time, the County needs to provide specific areas that it

would like to have studied. Kreutzfeldt provided eleven suggested study areas with

Commission approval, a few more can be added later. Current projects include chip

sealing in Lake County, stockpiling chips and mowing top cut on ditches where possible

with the signing project taking place. Discussion was held regarding the mowing of

County ditches. The mowing of County and Township road right-of-ways is permitted at
any time. The advertised July 10th regulation applies to SDDOT right-of-ways only.

Motion made by Gordon to convene as Drainage Commission. Second made by Butzke and motion carried.

Mic Kreutzfeldt, Drainage Administrator, reported on progress being made concerning the drainage complaint against Andy Tieszen

The Board reconvened as Board of County Commissioners.

Kris Graham and Laura Boone, Southeastern Behavioral HealthCare, met with the Board to discuss 2017 budget request \$5618, which represents one dollar per capita as noted in SDCL 27A-5-10. Funds received are used to subsidize outpatient services which include: individual counseling, family and group therapy, psychiatric services and home based family counseling. Multiple counselors work throughout the county providing home based services for children and families and outreach services to individuals with severe mental illness.

At 10:45 a.m. public hearing was held regarding application for transfer of alcoholic beverage licenses. Applicant: Hewitt Holdings LLC. Legal description: Lots 1, 2, 3 & 4 Battle Creek Shores Addition in Section 34, Greenland Twp. Peggy Hewitt was present. Applications are for Retail (on-off sale) Malt Beverage and Retail (on-sale) Liquor. Motion made by Dybdahl to authorize Chairman Scharffenberg to sign both applications. Second made by Gordon and motion carried.

Mike Fink, States Attorney, met with the Commission to discuss a proposed Attorney Fee Contract with Meierhenry Sargent LLP for the centrally assessed property tax appeal regarding TransCanada Pipeline. Fink noted that States Attorney's involved will be meeting with someone from the Meierhenry Sargent firm; no action taken at this time. Fink informed the Board that Law Enforcement is seeing an increase in cases involving mental health issues. Fink asked Auditor Sherman to contact Geoff Fillingsness with regard to the process of identifying dilapidated properties and reporting to the cities and county.

Alicia Petersen, 4-H Youth Advisor, met with the Commission to let them know that 6 candidates are being interviewed today for the permanent part-time position in the Extension Office. Petersen also noted that, at this time, she has a part-time assistant helping out and would like to keep this individual on call through Achievement Days as extra help while training the new hire. Request approved.
