It was noted that DENR regulates the site. States Attorney, Mike Fink, was present and recommended the Commissioners check the Zoning Regulations with Tracy Hofer, Zoning Administrator, to make sure that required procedures are followed.

Motion made by Gordon to convene as Drainage Commission. Second by Butzke and motion carried.

States Attorney, Mike Fink, informed the Commission that he is here at request of Mic Kreutzfeldt, Drainage Administrator, who is out of town. Michael Parham, who was present, has filed a complaint with Kreutzfeldt in reference to a ditch dug on Lot 1 in Subdivision of SW4 3-101-54; property owner, Andy Tieszen. With information provided, it appears that Tieszen is in violation of SDCL 46A-10A-30, which makes it unlawful to drain water without a permit, when such permit is required under the provision of a County Drainage Ordinance. Following discussion, Fink informed the Commission that a letter will be sent to Tieszen informing him that, within 30 days, the drain needs to be closed and the flow of water returned to what it was prior to the ditch work. Mike Laufman was present.

Auditor Sherman presented Ordinance 2016-01, an Ordinance Rezoning Property, for approval and adoption. Eric Schmitz was present. No other interested parties appeared. Motion was made by Dick to approve and adopt Ordinance 2016-01. Second made by Dybdahl and motion carried.
